### **INSTRUCTIONS**

- 1) The application must be completed legibly in block letters in the boxes provided.
- 2) In the introductory part, you must specify to which Governor you forward the application. The decision confirming holding Polish citizenship or loss of citizenship is issued by the governor competent for the place of residence or the last place of residence in the Republic of Poland of the person concerned, and in the event of the lack thereof - by the Governor of Mazowieckie Province.
- 3) In the introductory part "Address/Registered Office of the Applicant", in the line "Country/Province" you should give the name of the country where the applicant is residing (has the registered office) outside the Republic of Poland or the name of province if the applicant is residing (has the registered office) in the Republic of Poland.
- 4) In the introductory part "Additional information regarding the factual or legal circumstances pertaining to confirmation of possession or loss of Polish citizenship" you may clarify the scope of the request, add a date or circumstances which would refer to the possession or loss of Polish citizenship, such as a request to specify the legal basis for acquiring Polish citizenship, confirmation of possession or loss of Polish citizenship as of the date of death of the person concerned, etc.
- 5) All mandatory sections must be completed. If you do not know any specific facts, write "UNKNOWN" or "N/A", if the section does not apply to the person concerned.
- 6) If you need more space for explanations, attach a separate sheet of paper and make appropriate comments in the application.
- 7) In Section I(D), list all places of residence in the ascending order.
- 8) If you attach a copy of the governor's decision determining/confirming Polish citizenship held by the person concerned or his/her valid Polish identity card or Polish passport, do not complete Sections II and III of this application.
- 9) If you attach a copy of the governor's decision determining/confirming Polish citizenship held by at least one parent of the person concerned or parent's Polish identity card or Polish passport, do not complete Section III of the application.
- 10) In the line "Marital status" use one of the following terms: single, married, divorced, widow/widower, as of the date of filing the application or as specified on the death certificate.
- 11) You must attach all the necessary documents confirming the data and information included in the application, in particular any vital record certificates (birth and marriage certificates).
- 12) Pursuant to Article 40(4) of the Code of Administrative Procedures, an applicant residing abroad or having its registered office abroad shall indicate a service proxy in Poland if the applicant has not appointed an attorney-in-fact.
